Regular Meeting January 22, 2018

NASH COUNTY, NC SOUTHERN NASH SENIOR CENTER PROJECT FUND CAPITAL PROJECT ORDINANCE AMENDMENT 2

Be it ordained by the Nash County Board of Commissioners that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following Capital Project Ordinance is hereby adopted:

Section 1. The project authorized is the Southern Nash Senior Center Project for the purpose of construction of a Senior Center in the Southern part of Nash County.

Section 2. The officers of this unit are hereby directed to proceed with the capital project within the terms of this ordinance and all rules and regulations within North Carolina General Statutes as it pertains to capital projects and the budget contained herein.

Section 3. The following revenues are anticipated to complete this project:

RESOLUTION SUPPORTING ROADWAY IMPROVEMENTS ON SOUTH HALIFAX ROAD (SR 1544) AT KETCH POINT DRIVE

WHEREAS, traffic in the southbound lane of South Halifax Road (SR 1544) at Ketch Point Drive, a subdivision street in the City of Rocky Mount in Nash County, routinely backs up when a vehicle stops to turn left from SR 1544 into Ketch Point subdivision; and

WHEREAS, South Halifax Road is a two lane roadway at this location and southbound drivers may leave the pavement to pass the turning vehicle on the right shoulder, resulting in a dangerous condition; and

WHEREAS, the situation is magnified during peak hours when both congestion and turning movements are at their height; and

WHEREAS, installation of a left turn lane within the existing right-of-way at this location would mitigate both the safety and congestion concerns, having a high impact on the conditions at a low cost;

NOW THEREFORE, be it resolved that the Nash County Board of County Commissioners hereby supports the installation of a left turn lane from Halifax Road (SR 1544) at Ketch Point Drive by NC Department of Transportation.

The Nash County Board of Commissioners, as authorized by North Carolina General Statute 153A-92, has set the starting salary for the Sheriff position as provided below. This will affect the individual elected to this office, when they take office. All other compensation elements are set forth in the Nash County Personnel Policy.

The starting salary for the Sheriff Position will be \$77,576 annually.

This Resolution will not be altered or amended until after the person elected as Sheriff in the 2018 election takes office. Thereafter, the Board of Commissioners may adjust the starting salary of the candidate elected considering the years of service and performance in related experience of the person elected.
